Ladies and Gentlemen,

When China decided to embark on its reforms and opening up journey in the late 1970's, a lot of attention was paid to modernization and advancement of science and technology which gradually contributed to China's overall progress and economic prowess. Today China is leading the world in terms of ICT, artificial intelligence, big data, 5G and other emerging and cutting-edge technologies.

In this regard, Zhongguancun, rightly termed as China's Silicon Valley, has played an instrumental role in incubation, facilitation, development and nurturing of Chinese tech start-ups and has enabled the country to transform its nascent IT industry into a global technology leader.

In Pakistan too, we are trying to replicate the successful model of Z-Park by instituting special technology zones. STZA was conceived with this objective in mind.

Cooperation in science and technology also forms a major component of our bilateral ties and has recently gained a lot of attention from the leadership and people of our both countries. We have dedicated joint working groups on science and technology and on ICT, under China-Pakistan Economic Corridor (CPEC). Recently our two countries also decided to launch a number of new, domain-specific and specialized corridors with China-Pakistan Digital Corridor being one of them.

Recently, Pakistan's Prime Minister visited Beijing earlier this month, and in his meetings with Chinese Leadership, it was identified as a key area of close cooperation, as part of bilateral agenda.
